2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

5. Warranty Clause :

- A. The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all recent improvements in design and materials unless prescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- B. This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract.
- C. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- D. Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.
- E. In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- F. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.

6. Anti-bribery Clause:

By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.

7. GST Return:

8. Liquidated Damages:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

9. ZED & LEAN Certification :

- ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content.
- iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'Air compressors' offered including all warranty obligations as per the general and special conditions of contract.

11. For Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided:

- A. their principal manufacturer meets all the criteria above without exemption, and
- B. the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
- C. the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar "Air compressors" for past three years ending on '31st March 2024'.

12. For Existing successful Past Suppliers: In case the bidder (manufacturer or principal or authorized representative) who is a successful past supplier of 'Air compressors' in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.

13. Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

14. Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Startup enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

16. O & M MANUALS:

- 16.1 Three sets of Operation & Maintenance Manuals in English language and its soft copies in CD should be supplied along with the equipment. Manuals should contain the below information in it.
- 16.2 Operating manuals of Compressor including other items like Air Filter, Air Drier etc.
- 16.3 Detailed Maintenance manual of Compressor including other items like Air Filter, Air Drier and Air Receiver etc. With the help of drawings of main assemblies/sub-assemblies/parts including Electrical / Coolant / Hydraulic circuit diagrams.
- 16.4 Catalogues, Operation & Maintenance Manuals of all bought out items including drawings, wherever applicable.

17. QUALIFYING CONDITIONS for Non-MSE firms:

- 17.1 Name of the customer / company where similar Compressors are installed.
- 17.2 Complete postal address of the customer.
- 17.3 Month & Year of commissioning.
- 17.4 Board specification of the machine (S).
- 17.5 Name and designation of the contact person of the customer.
- 17.6 Phone, FAX no. and e-mail address of the contact person of the customer.

- 17.7 "Performance certificate from the customer regarding satisfactory performance machine supplied to them(Original Certificate or Through E-mail directly from the customer). The original performance certificate may be returned after verification by BNP, if required."
- 17.8 BNP reserves the right to verify information submitted by vendor. In case the information is found to be false / incorrect, the offer shall be rejected.

18. GENERAL CONDITIONS:

- 18.1 L1/Qualified firm must visit the BNP site before supplying the air compressor along with auxiliary equipment.
- 18.2 "The supplier is to submit a clause wise deviation statement against each clause of this technical specification along with the offer."
- 18.3 Anti-Vibration Mountings should be provided on the compressor frame for vibration isolation from Screw element, Motor and Oil Separator Tank.
- 18.4 Guarantee: Vendor shall provide full and complete guarantee for two years trouble free performance from date of commissioning.
- 18.5 "Delivery: Delivery period is as follows
i. For Supply, Installation, erection, Testing and commissioning at site- 120 days after issue of PO."
- 18.6 Packing: Compressor unit and all items shall be dispatched in suitable packing to avoid ingress of dust and handling, transit and storage.

20. Important Note:

- 20.1 Offer should be completed in all respects.
- 20.2 Technical literature and catalogues of the offered compressor, air dryer, pre-filter & control panel etc. should be sent along with the offer / quotation.
- 20.3 Supplier should confirm and clarify each clause / pointwise as given above at the first instance.
- 20.4 Make of the compressor -: **ATLAS COPCO/ELGI/KIRLOSKER/KAESER/CHICAGO or any reputed make.**
- 20.5 The above technical specifications are the minimum technical requirement. However, any better solution will be preferred.

21. Special instructions to bidders:

- A. For the removal of hot gases from the condenser fan suitable ducting system shall be in vendor scope.
- B. All power and control cable shall be in vendor scope of work. Also cable tray and cable laying work shall be in vendor scope of work. All earthing wire, strip, power cable and control cable shall be copper. All power cable shall be copper, XLPE, armoured, FRLS as per latest IS

/IEC standard.

- C. Suitable interconnection with existing receiver tank shall be in the vendor scope.
- D. Firm have to provide the suitable capacity of filter in the outlet of compressor to maintain the air conform to class 1 quality.
- E. For the acceptance of compressor, seven day trial run of compressor shall be conducted at BNP for the issue of FAC.
- F. Suitable air net pipeline along with valve to maintain the interconnect the discharge line shall be in the vendor scope.
- G. Consumable item (air filter, oil filter, oil separator...Etc.) for the running of machine during the warranty period shall be in vendor scope.
