## Technical Specifications of Calibrated Underlay Packing Plastic Films

1. Very high quality calibrated under packing plastic films to be used as underlay packing of relief plates (metal backed Nylo plates) & Orlof/ Collector blankets of the security printing machines in the following dimensions -
  - (i) Plastic Packing Film – 0.100 mm = 685 x 840 x 0.10 mm
  - (ii) Plastic Packing Film – 0.200 mm = 685 x 840 x 0.20 mm
  - (iii) Plastic Packing Film – 0.250 mm = 685 x 840 x 0.25 mm
  - (iv) Bi-layer Packing Film – 0.900 mm = 820 x 830 x 0.90 mm
2. Thickness of the films must be perfectly accurate throughout the surface so that it does not affect the squeeze-pressure/ impression properties in the fine print quality of the printing machine.
3. Temperature of the Nylo/ relief plate's cylinder is constantly maintained at any set temperature between 20-35 °C. Similarly temperature of the Orlof/ Collector blanket is constantly maintained at any set temperature between 27-47 °C. Hence, the films must be suitable to bear the set temperatures, be dimensionally stable & give long service life.
4. First 03 films of the above chart are used in different combinations, hence, back of these films must be non-sticky and rigid/ pliable enough to handle & fix two or more films together.
5. 04<sup>th</sup> item of the above chart (bi-layer sheet of 0.9 mm thickness) has a 2-layer composite structure, one side soft & other side hard plastic film (**Make Folex Folabase Soft-U or equivalent**). This item can have a self-sticky back at hard-side (optional) or it must be compatible with adhesive-spray (3M Super 77 or equivalent) when used to stick it on the orlof cylinder.
6. **Make: Folex or equivalent.**
