1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

TECHNICAL SPECIFICATION FOR TRICRESYL PHOSPHATE

1. Specification:-

- (iii) Colour: light yellow
- (iv) Formula: $(\text{CH}_3\text{C}_6\text{H}_4)_3\text{PO}_4$
- (v) Odour: Odourless
- (vi) Flash point: 238 °C Min
- (vii) Specific Gravity: 1.208 ± 0.005 at 25 °C
- (viii) Vapour pressure: 0.03 mmHg at 25 °C
- (ix) Solubility Insoluble in Water
- (x) Vapour Density (Air=1) 12.7

2. Quality Requirements:-

The supplied chemicals must produce defect-free PVC paste having the following characteristics:

a) Mixing Quality

- The Paste should have Homogeneous mixing without lumps
- The Paste should not have air bubbles or foaming
- The Paste should have Uniform dispersion of plasticizers and additives
- The Paste should have Consistent viscosity throughout the paste

b) Process Stability

- The prepared Paste must remain stable during heating
- The Paste should not have premature gelling
- The Paste should not have separation or settling of resin
- The Paste should have Stable flow behaviour during application

c) Coating Performance of TCP along with other ingredient like PVC Resin and Graphite etc.

PVC paste must allow:

- The Paste should have Smooth coating on wiping cylinder surface
- The Paste should have Proper bonding with base metal
- The Paste should have Zero pinholes / cracks / blisters
- The Paste should have Uniform thickness across full width
- The Paste should have High flexibility and elasticity



3. Performance Requirements

The chemical must deliver defect-free PVC coating that ensures:

a) Hardness Performance

- The Coated Cylinder should have Hardness uniformity across the full surface
- The Coated Cylinder should not have soft spots, over-hard patches, or hardness fluctuation
- The Coated Cylinder should have Long life & high abrasion resistance during printing cycles

b) Wiping Effect & Machine Function coated cylinder must provide:

- The coated cylinder should have Clean and uniform wiping effect
- The coated cylinder should have Equal ink removal across printing width
- The coated cylinder should not have streaking, patching, or uneven wiping
- The coated cylinder should have Smooth, vibration-free operation on the machine
- The coated cylinder should have Optimal friction & grip suitable for high-speed printing

4 Testing and Machine Trial:-

The chemical must pass the following Criteria conducted on purchaser's premises:

- The Coated Cylinder should have uniformity across the Surface.
- The Cylinder should Pass Hardness test (70 Shore A as applicable on wiping cylinder)
- Wiping performance test on actual printing machine @ 80° Celsius with machine speed 10000 sheets/Hour

Note:-

1. If coating defects, wiping issues, → Purchaser may reject material without any financial obligation.
2. In case of any conflict of test reports, the purchaser's test results shall prevail and shall be final for acceptance or rejection.
3. Supplier should provide Laboratory report of chemical analysis from Government approved laboratory/OEM, Shelf Life and Material Safety Data Sheet (MSDS) for the product.
